

Canadian Ski Instructors' Alliance Election of Directors

The Board of Directors of the CSIA consists of six (6) elected and voting persons. In accordance with CSIA's General By-Laws, the term of office for the Director of the **Ontario** and **British Columbia** regions will expire on May 1, 2017.

Any member in good standing who wishes to stand for election to the Board of Directors for either positions in question must, **no later than November 30, 2016**, submit a Nomination Form, supported by not less than ten (10) members, to the secretary of CSIA's Head Office. Qualification

In accordance with Article 6.04 of our General By-laws, the following restrictions shall apply to the election and appointment of directors:

- (a) Only members who reside in a particular region may be elected by the members of such region pursuant to subsections 6.01 a).
- (b) No member who is a director of the Canadian Ski Coaches Federation or a director of the Canadian Association of Snowboard Instructors shall be qualified for election to the board of directors of CSIA by the members pursuant to subsections 6.01 a).
- (c) No member who is an employee of the CSIA or who is a contractor providing services to CSIA as a Level 1 course coordinator, a professional development program coordinator or an educational development coordinator shall be qualified for election or appointment as a director.
- (d) No member who is less than eighteen (18) years of age; of unsound mind, and has been so found by a Court in Canada or elsewhere; not an individual; or who does not have the power under law to contract shall be qualified for election or appointment as a director.
- (e) No member who is not a resident of Canada shall be qualified for election or appointment as a director.

Election Process Timelines

As per our General By-Laws, please find herewith a brief description of the election process timelines.

1. November 30th, 2016 deadline for submission of Nomination Form to stand for election.
2. Profiles of all Nominees will appear in the **March 2017** edition of Skipromag.com.
3. Start of election: The voting ballots will be available no later than **March 15, 2017** under the "News" section of our website snowpro.com or accessed through your personal profile; for use by those members **in good standing** residing in the **Ontario** and **British Columbia** regions only.
4. Deadline for election: Duly completed voting ballots will be accepted until **April 15, 2017**.
5. The election results will be announced in a communication to the members, shortly after the validation and tabulation of the results.
